Ogden, Murphy & Wallace

Issues:

- "Is it reasonable that the President believed it is her right to seek legal counsel." It shown that it was not common practice for President to seek legal counsel without board support.
- Limit scope of a individual board member's power as to not allow unauthorized expenditures.
- No one board member can obligate an HOA members for expenses without the support of the entire board.

- President maintained that it is within her position to seek legal counsel without board approval and that she has no liability for doing so.
- Motion was made that two board members would reach out to the attorney's office to seek mitigation of the bill and to ask for a report of the matters discussed.

- Addition of names on Keyhole contact list We need more homeowners trained in the septic so their name can be added to the contact list when the drainfield alarm rings.
- Consider co-chairman for Septic Committee: Gary Francois, Dan Bigos & Larry Morgan.
- Enclosure for Keyhole panel needed to allow Spectrum service. Can't move forward with changing to Spectrum unless we build an enclosure for panel. Investigate purchasing enclosure. Will purchase an enclosure if it is under \$100.
